# **Registration Fee**

First time enrollment fee: \$250 (non-refundable) Re-enrollment fee: \$200 (Non-refundable)

## **Wait-List Fee**

If applicable, a wait-list fee of \$150 will apply towards the registration fee, when a space opens up.

## **Tuition Deposit**

A one-month tuition deposit is required and due at the time of enrollment. This will apply to the last month's tuition of the child's contract year. The one-month's tuition deposit will **NOT** be refunded if the child fails to complete the full school session.

## **FACTS**

- Monthly tuition payments are made to FACTS Tuition Management via automatic bank payments on the fifth (5<sup>th</sup>) of each month.
- A late fee of \$35 will apply for tuition paid after the 5<sup>th</sup> of the month.

<u>Inclement Weather Fee for School-Age</u>: \$20/hour will apply if a School-Age Extended Day child stays on an inclement weather day beyond the number of scheduled hours allotted for that day.

<u>Sibling Discount</u>: 10% discount applied to the lesser tuition amount when siblings attend concurrently.

# **Additional Hours**

- Authorized non-contract hours (before closing): \$25/hour with 24-hour advanced notice.
- Unauthorized non-contract hours (before closing): \$30/hour.

#### Late Pick-Up Fees

After 5:30 P.M., the late pick-up fee is \$2/minute for the first 10 minutes, \$4/minute for the next 10 minutes, and \$6/minute thereafter, until the child is picked up.

**Program/Schedule Changes:** A 30-day's written notice is required to change the child's program/schedule.

1<sup>st</sup> change: free of charge 2<sup>nd</sup> change: \$50

3<sup>rd</sup> change: \$75 Every change thereafter: \$90

<u>Withdrawal</u>: A written notice must be submitted at least 30 days prior to the first day of the month during which the child will cease to attend.

 The school reserves the right to dismiss new or continued enrollment for a child, if at any time, for any reason not prohibited by law, in the sole judgment of The Learning Village Montessori, the school feels that it cannot meet the needs of a child or family.

\* All monthly tuition payments are equal, regardless of holidays, student absences, teachers' in-service days, closures/isolations due to COVID-19 related incidents, or school closures due to inclement weather, natural disaster, or an "Act of God," which prevents school operations.
